Tim also received EMT of the Year and was presented with a plaque.

Chief's Report:

Camp Lutherwood - There was a significant fire at the camp this weekend. No one was on site at the time the fire started and by the time the fire was visible from the road and someone reported it, the structure was fully involved.

Hwy 126 Collision - Chief Ney reported there was a bad head-on collision on Hwy 126 just east of Fisher Rd. One patient was ejected 30 feet from the vehicle.

Rescue Boats - One of LFA's rescue boats was taken for a trial run today. The district has two rescue boats at Fern Ridge Lake, one at the north end and one at the south. There will be refresher training for boat operators.

Water rescue is not our primary mission however it is good for public relations and a great morale booster.

Crow Station Project – The station is nearing completion: the outdoor slab has been poured, the final painting and finish work is in process and bath fixtures are being installed. The generator at one of the SCF stations will go to the Crow Station.

| Discussion | Chief Ney handed out a draft agreement from the attorney regarding a loan between SCF and LFA for the purchase of a medic unit. There are a couple of options: 1) The purchase amount would come from SCF to LFA with LFA making the purchase. SCF makes the purchase and LFA purchase the unit from SCF with the annual payment from SCF to LFA adjusted for a period of two (2) years. Both boards prefer option number two (2). Chief Ney will relay this to the attorney and finalize the agreement. Language will be included delegating authority for both board presidents to sign the agreement. |
