Pursuant to the authority of Resolution No.2022-2023-07 adopted by the Board of Directors of the District (the "Board") on June 20th ,2023 (the "Resolution"), which Resolution is in full force and effect, authorizing, among other things, the negotiated sale of the District's \$1,000,000 Tax and Revenue Anticipation Note, Series 2023 (the "Note"), I have:
- (a) reviewed and accepted the proposal submitted by Kitsap Bank (the "Bank"), for the purchase of the Note;
- (b) negotiated the terms of and entered into a Note Purchase Agreement (the "Agreement") dated on or before July 7th, 2023, by and between the District and the Bank;
 - (c) established the payment terms and conditions with respect to the Note;
