## **Chief's Report:**

Santa Clara Board Meeting – Chief Ney attended the SC Board Meeting Tuesday. A draft of the contract between the two districts was presented during the meeting. Chief Ney is very encouraged and feels that, at this point, the districts will make it work. Challenges that may come up will be dealt with as they arise.

**Work Group** – The group is continuing to work on a staffing model to improve coverage. A lot of money has been spent on overtime which LFA cannot sustain - the group is working toward alleviating overtime as well as more efficient staffing. Hopefully buy the April board meeting a draft of the plan will be available.

Crow Station Project – A budget for the project has not been finalized. Expenditure guidelines have become more restricted and LFA's portion of the project may be higher than originally anticipated. Expectations were based on previous grants. More details will be available during the next board meeting.

This ordinance would give the district jurisdiction to enforce provisions of the ordinance throughout LFA territory, including cities. Chief Ney read the ordinance in its entirety.

If approved by the board, a copy of the ordinance will go before the Veneta City Council, and the Lane County Board of Commissioners to be adopted.
